defended multiple public companies in securities lawsuits, helping to secure the dismissal of claims against companies such as 3M, Morgan Stanley, and Credit Suisse.

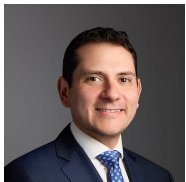
