The Distinguished Board Service award recognizes Darpan's work over two years as the SABA-NC Gala co-chair and helping organize an event that brings 250+ attorneys together.

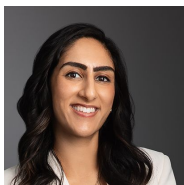
